

Terms and Conditions:

- Basic Education Qualification is Matric.
- For Selection Purpose 10th and 12th Pass (Qualification only) shall be considered and 90% weightage shall be awarded to 10th Pass and 10% to 12th Pass on Prorata Basis, no Weightage shall be given for any higher qualification. There shall be no VIVA VOICE while making the Selection for Class IV Vacancies, in light of the Government rules.
- Age as on 01-01-2018, for Open Merit Candidates, shall be 18-40 Years. However, Upper age limit relaxation in respect of reserved categories is 43 years in case of SC/ST/ ALC/RBA/OSC.
