In order to have a strategic development of Horticulture sector advanced technologies developed across the globe have to be introduced and adopted for the up-liftment of farming community in order to enhance the GSDP of Jammu and Kashmir State. The innovative technologies in the temperate regions particularly technologies developed by the Dutch people in the production of temperate fruit crops have be found to be beneficial in increasing the productivity besides, impact of the total production.

The Directorate of Horticulture intends to establish a center of Excellence at Zawoora Orchard Srinagar, Kashmir wherein cultivation of various Horticulture crops will be taken up utilizing Indo-Dutch Technologies such as cultivation of various fruit crops in the High Density format, protected cultivation in respect of various remunerative crops etc. Expression of Interest (EOI) in sealed covers are invited for selection of executing agency of national/International repute who will be responsible for the establishment of various requisite structures, establishment of High Density Orchards for various fruit crops like Apple, Pear, Cherries, Prunes etc and to give a handhold support for upto 3 years after the completion of structures. Interested agencies may download the Offer (EOI) including format of Technical Offers and details of different activities etc. to be undertaken from the Departmental website <http://Jktenders.gov.in>. The bidders are at liberty to visit the site before the date of Pre-Bid presentation. The offer should be submitted in sealed cover with supported documents. The Offers will be opened on 04.03.2017 and the Financial bids will be invited separately as per detailed documents from those bidders who will qualify the Technical evaluation and fulfill the eligibility criteria and submit the documents required for qualification. The quotationers or their authorized representatives shall remain present during opening of the Offers (EOI). The undersigned reserves the right to reject all or any Offer without assigning reasons what so ever. EOI are invited for selection of Executing Agency of National / International repute who will be responsible for designing, establishment of structures, technology stabilization for cultivation of crops which are mentioned and to give hand hold support up to **a period of 3 years** after commissioning of the project.

Technical Offer

Activities that will be undertaken by the Agency/Firm:

A. Establishment of the following infrastructures with successful cultivation under the prevalent climatic conditions on site.

- Development and complete layout of the land in the significant blocks over an area of about 13 Hectares.
- Laying and cultivation of pome fruit orchards on the dwarf root stocks like M-9, B-9, Emmla MM-106, Emmla MM -111 and in case of Apple with requisite training systems and raising Pear and other Orchards on dwarf root stock like Quince-C BA-29 etc in V-Trellis design of High Density, moderate density formats over an area of 6 Hectares.
- Laying and cultivation of Cherry and other stone fruits in High Density/moderate Density formats over an area of 3 Hectares.
- Laying and cultivation of Nut crops like Walnut, Almond, Pistachio etc over an area of 3 Hectares.
- Laying and cultivation of fruit plants particularly temperate fruits under protected cultivation.
- Installation of protected structures alongwith the Green House and Shad House over an area of 450 Sq. meters and 180 Sq. meter respectively.
- Propagation of fruit plants like Apple, Pear and Stone Fruits etc over an area of 1 hectare.
- Propagation of fruit plants like Walnut, Almond, Kiwi, Olive, Pistachio Nuts, Hazel Nuts, Berries etc under controlled conditions in 450 Sq. meters capacity.
- Installation of Micro-irrigation regimes for raising quality fruit crops in an open and control conditions.
- Installation and transformation of database of high power weather station and its utilization for the management of various diseases/pests.
- Use of pneumatic pruners for the training/pruning of temperate fruit plants.
- Professional manpower for the establishment of latest soil testing facilities and their operational functioning.
- Professional manpower for disease diagnosis with knowledge of isolation techniques and management thereof.
- Latest machine in use for the cultivation of fruit plants.
- Installation of power backup facilities and its capacities to be given.

B. Three years hand holding support for the management of the crops and structures.

C. Sustainability of the project has to be described and proved.
