For and on behalf of governor of Jammu and Kashmir State, sealed Global tenders are invited from reputed/registered fruit plant Nursery Growers for supply / import of different fruit plant material as listed here under directly or through their local agents /importers:

Instruction for bidders regarding e-tendering process :-

- i. Bidders are advised to download bid submission manual from the “downloads” option as well as from “bidder Manual Kit” on website www.jktenders.gov.in to acquaint bid submission process.
- ii. To participate in bidding process. Bidder has to get ` digital signature Certificate (DSC). As per information technology Act-2000 .Bidders can get digital certificate from any approved vendor.
- iii. The bidder have to submit their bids online in electronic format with digital signature .No bid will be accepted in physical form.
- iv. Bids will be opened online as per time schedule mentioned in Para-1.
- v. Bidders must ensure to upload scanned copy of all necessary documents with the technical bid. Besides, original/photocopies of documents related to the technical bid be submitted physically/by registered post/through courier before date specified in Para -1.

Note:-Scan all the documents on 100 dpi with black and white option.

Rs:1000/- as the cost of the tender document shall be furnished in shape of Demand Draft/Cash at the time of collection /submission of the tender documents the demand draft shall be pledged in favour of Accounts Officer, Directorate of Horticulture, Kashmir, J&K Govt.

Specifications:-

- a. The Plants be free from pests/diseases and shall carry a certificate that it is free from diseases/pests including virus for which necessary certification from registered/competent certifying authority needs to be provided by the supplier.
- b. The entire root system of plant must be intact and viable. The plants must be uprooted and packed in presence of authorized representative of the Department.
- c. The plants must be at least 4 feet (122 cms) from the bud union.
- d. The girth of the plants above the bud union must be not less than 35 mm and the plants must be 1 year old with at least 3+ feathers.

Terms and Conditions:-

- I. The number/kind of fruit plants mentioned against each cultivar/variety is tentative and is subject to the change on the below mentioned grounds.
 - a. **Quantity available in stock.**
 - b. **Availability of planting material in the selected lots.**
 - c. **Demand as per the potential/scope.**
- II. Plants must be supplied by a reputed/registered/genuine source.
- III. Legal profile/Phytosanitary certificates as may be required either in the country of origin or in the importing country will be provided by the suppliers.

The suppliers will quote rates per plant FOR Srinagar in the following format:

- IV. The supplier/bidder will be responsible to fulfill all formalities of the supply/import of the plants themselves or through their authorized agents and supplies/import of plant material by the supplier shall have to be made at Srinagar.
- V. The import/supply of plants shall be made by the bidders and Department of Horticulture will not be party in the process of import of the plant material and supplier will have to ensure its safe/timely delivery himself in the designated destinations at Srinagar.
- VI. Bids must be accompanied with earnest **money of 2% of the bid amount** in the form of FDR/CDR in favour of Accounts Officer, Directorate of Horticulture Kashmir, J&K Govt. payable at Srinagar. J&K, India.
- VII. Kind wise/variety wise number of plants to be imported will vary. The minimum number of any particular variety will be at least 50 (fifty). The exact number of plants of each variety will be communicated in Supply Order.
- VIII. The laboratory tests as may be necessary for issuance/implementing quarantine regulations will be followed strictly.
- IX. All the relevant certificates issued by competent authority in Country of origin be submitted at the time of shipment of goods.
- X. The plants must be properly packed, tagged and dispatched.
- XI. The suppliers/bidders will quote technical and financial bid separately in two separate envelopes and should be marked on the cover of the envelopes as "Technical Bid" or "Financial Bid". The envelope of each bid should be having address/cell No./Mail ID of the bidder, printed or hand written on the cover/envelope.
- XII. The fruit plants must be true to type, with a certificate of genuineness from competent authority.
- XIII. In case the supplies made by the suppliers/bidders are not found as per the specification laid down in the tender notice and other certified documents, the concerned supplying agency including the certifying authorities will have to face legal course of action.
- XIV. The Department will be at liberty to add or alter any terms and conditions while finalizing the supply order/agreement, which will be a binding on the supplier/bidder.
- XV. Suppliers/bidders will also enclose their details of experience in rising of fruit plants/supply of plant material, literature/printed brochures of their stocks with the Technical bid.
- XVI. The price quoted for fruit plants will be valid for the financial year 2017-18 (upto 31th March 2018).
- XVII. It shall be exclusive right of Divisional Level Purchase Committee/competent authority, J&K Government (for procurement of planting material) to accept or reject any or all offers including lowest offer either wholly or partly without assigning any reason thereof.
- XVIII. **Delivery schedule.** Last date of delivery of material at Srinagar will be communicated in the supply order.
- XIX. Payment shall be made through LC mode after the satisfactory physical receipt of the consignment.

- XX.** In case of LC all bank charges (including LC confirmation charges) payable outside India will have to be borne by the supplier only.
- XXI.** In case any clause of the terms/condition as laid down above is affected by force majeure, then the decision of Secretary Horticulture J&K government or his authorized representative will be final.
- XXII.** Hon'ble Court of Srinagar, J&K, India alone will have the jurisdiction to settle disputes, if any in respect of the present Global Tender.
- XXIII.** The stocks will have to be supplied in dormant conditions and precisely without signs of sprouting.
- XXIV.** The offer must reach to Directorate of Horticulture, Kashmir opposite presentation Convent School, Rajbagh, Srinagar, J&K India, Pin code 190008 by or before **13-05-2017 upto 4:00 PM**. Parties who are interested to have the copy of detailed terms and conditions may collect the same from the office of **Director Horticulture, Kashmir** during office hours or download the required documents from departmental website <http://hortikashmir.gov.in> . - XXV.** The tenders will be opened on **15-05-2017 at 2:00 PM** in the office of **Directorate of Horticulture Kashmir opposite Presentation Convent School Rajbagh, Srinagar Kashmir J&K**, India and the parties who are interested to participate in the opening process of bids are at liberty to participate in person or through their authorized representatives.
- XXVI.** Only those suppliers are eligible to participate in the tender process who have plant material on ground.
- XXVII.** The taxes as admissible/applicable at the time of procurement shall be levied on the supplier.
