For and on Behalf of the Lieutenant Governor of Jammu & Kashmir Union territory, Sealed tenders affixed Rs 2/- revenue stamp, are invited for auction of **standing non- fruit bearing and fruit bearing trees existing in Departmental Fruit Plant Nurseries, Seer and Lisser of district Anantnag the details are given hereunder:**

The detailed tender notice and prescribed tender form, will be made available to the interested persons upto **23 /10/2024** on all working days(**upto 4:00pm**) against proper application with photocopy of the identity card of the applicant and on payment of Rs 20/= each which is non refundable. No proxy application will be entertained.(Non-Refundable)

Tenders, should be sealed properly in envelopes after fixing gum and tape on all sides are to be deposited in the tender box available in this office by or before **23/10/2024(upto 4:30pm)**. The quotations will be opened by the constituted committee on **24 /10/2024 at 11:30 A.M** at CHO Office Anantnag in presence of quotationers who wish to be present, In case of Holiday or due to unavoidable circumstances on the fixed date or due to unavoidable official engagements of the Chairman, the tenders will be opened on next working day on same time and venue. The bids must be accompanied with **Rs.15000 for Seer Nursery and 5000 for Lisser Nursery** in the form of CDR pledged in favor of the Chief Horticulture Officer Anantnag.

Terms and condition:-

1. The Auction committee shall have the discretion of re-auctioning if it feels necessary to do so to safeguard the interest of the Government.
2. The successful bidder shall have to deposit 50% of the auctioned amount at the time of the opening of the bid and the remaining 50% within 03 days.
3. The CDR deposited with the tenders should bear the name of the tenderer /agency.
4. Payment of auction in the form of a cheque will not be accepted.
5. In case the committee is not convinced that the highest bid offered is not a genuine offer for the auctioned Trees, the committee reserves the right to cancel the offer. As Such the highest bid alone should not necessarily make the bidder eligible for the contract or considered as a successful bidder. The committee can invite the fresh tenders to make the appropriate arrangement for the auction of trees on communicating the approval of the bid/offer, if the successful offer/bidder fails to deposit the auction amount and execute the agreement within the specified time limit and shall be considered as backing out from the contract by the concerned. The department in that case shall be within its rights to decide the matter on its merits or allot the contract to 2nd highest bidder or may re-auction the Trees. Loss if any sustained by the Government on this account shall have to be made good from the defaulting contractor through the concerned Tehsildar. Recoveries will be made and deposited in the government Treasury besides initiating action against the defaulter.
6. A successful bidder who fails to execute the contract shall be deemed to have been "black Listed" for future auction process.

7. The auction committee reserves the right to reject any offer in full or part thereof, without assigning any reason thereof.
8. For smooth implementation of contract instructions as may be deemed necessary and issued by the Department from time to time will be binding on the successful bidder and deemed to be part of the contract/agreement.
9. The successful bidder shall have to fully uproot the stubs of the auctioned plants and no stubs shall remain on the spot.
10. The successful bidder shall have to lift the material within 10 days of the auction.
11. **Interested Parties/ Persons can visit the nursery during office hours up to 23 -10-2024 with permission of the Horticulture Development Officer Seer & Lisser .**
